Expanding Evidenced Based Practices

New Mexico Medicaid is currently offering specific rates (pending CMS approval) for these five specific Evidenced Based Practices (EBP)

- 1. Multisystemic Therapy (MST)
- 2. Functional Family Therapy (FFT)
- 3. Trauma Focused Cognitive Behavior Therapy (TF-CBT)
- 4. Eye Movement Desensitization and Reprocessing (EMDR)
- 5. Dialectical Behavior Therapy (DBT)

These EBPs were selected by the State for specialized rate development. This is not a definitive list of all EBPs available in the State.

Future rate development could include additional EBPs, that process is overseen by HSD with CYFD involvement.


Goals of EBP Expansion Initiative

- To reduce barriers to access by providing training and support to providers delivering specific EBPs
- 2. To increase delivery of quality behavioral health care for residents in NM
 - a) Children and adolescents in child welfare system
 - b) Other Children and Adults with Medicaid

Providing Services While Working Towards Certification

- Approval for the specialized rates requires approval by the state.
- Each evidence-based practice has its own criteria for approval, which are aligned with national certification standards.
- Full certification in these models takes time, up to 2 years for some of them.
- Providers are able to provide EBP services and bill under <u>regular</u> therapy codes until they reach training or certification standards.
- State is committed to supporting providers to achieve approval through access to training, consultation and technical assistance.

Multi Systemic Therapy (MST) Qualifications

MST is an intensive in-home-, family- and community-focused treatment for youth ages 12-17 with serious externalizing, antisocial or delinquent behavior.

Criteria for approval for specialized rates

- Engaged in training, ongoing fidelity oversight and issued an MST License through MST Services LLC, or any of its approved subsidiaries, including Rocky Mountain MST Network
- Providers must enter into an agreement directly with Rocky Mountain MST Network or other MST Network Partner for clinical training, consultation, quality improvement and ongoing fidelity oversight.
 - Currently, the state will sponsor training and consultation for new teams through COI
- Teams will participate in training, consultation, and ongoing continuous quality improvement according to the Rocky Mountain MST Network model.

*Those who are currently MST licensed and billing will be migrated to the new rates once approved by CMS.

• COI will work with current and new MST providers to onboard into the new system

Functional Family Therapy (FFT) Qualifications

FFT is intensive, short-term, family-based treatment for youth ages 11-18 exhibiting problematic behaviors and at-risk for justice system involvement or out of home placement.

Criteria for approval for specialized rates

- Currently engaged in training and ongoing fidelity oversight through FFT Partners or FFT LLC
- Providers must work directly with FFT Partners for clinical training, consultation, quality improvement and ongoing fidelity oversight, according to their model
- Currently, the state will sponsor training and support for new teams with FFT Partners

Trauma Focused CBT (TF-CBT) Qualifications TF-CBT is a short-term, evidence-based treatment model for children and adolescents ages 3-18 who were impacted by trauma and their parents or caregivers.

Criteria for approval for specialized rate

- TF-CBT Certification by the TF-CBT National Therapist Certification Program (TFCBT NTCP)
 - 1. Completion of online (11 hours) and two days in person training
 - 2. Twelve months of consultation
 - 3. Completion of three separate TF-CBT treatment cases
 - 4. Taking and passing TF-CBT Therapist Certification Program Knowledge-Based Test.
- Maintain certification requirements set forth by TFCBT NTCP

Eye Movement Desensitization & Reprocessing (EMDR) Qualifications EMDR is a structured therapy for children and adults who have experienced a trauma and are having symptoms associated with Post-traumatic Stress Disorder (PTSD).

Criteria for approval for specialized rate

- Demonstrated completion of EMDR Basic Training OR EMDR Certification by EMDRIA (EMDR International Association)
 - Completion of EMDRIA approved Basic Training
 - 20 hours Instructional
 - 20 Practicum
 - 10 hours Consultation
 - EMDRIA Certified Therapist requires additional consultation, training and letters of recommendation
- Maintain certification requirements set forth by EMDRIA

Dialectical Behavior Therapy (DBT)

DBT is a comprehensive treatment for people who experience intense emotion dysregulation that is interfering with their daily lives, relationships and personal goals. Serves adolescents and adults.

Criteria for approval for specialized rates

- Providers must be actively engaged in a DBT Team delivering all components of DBT
 - DBT skills training group
 - Individual DBT therapy
 - DBT coaching
 - Participation in DBT consultation team
- Certified DBT Clinician by the DBT Linehan Board of Certification (DBT-LBC)
 - Additional clarification about team requirements to follow
- Maintain certification set forth by DBT-LBC
